



IN RE: Amend Resolution 2009.08.03.04 Renewal of Vision Coverage with Vision Service Plan


WHEREAS, Resolution No. 2009.08.03.04 Renewal of Vision Coverage with Vision Service Plan was approved on August 3, 2009; and,

IN RE: Renewal of Vision Coverage with Vision Service Plan

WHEREAS, the present vision insurance coverage by Vision Service Plan expires at midnight on August 31, 2009; and,

WHEREAS, requests for proposals were sought by McGohan/Brabender, our agent of record; and,

WHEREAS, the Township Administrator and his Administrative Assistant have examined all materials, quotes and prices available to the Township; and,

WHEREAS, the insurance premium rates given by Vision Service Plan reflect a minimal increase in premium which includes an upgrade of our in-network allowances,

NOW THEREFORE, BE IT RESOLVED, that this Board of Sugarcreek Township Trustees renews this contract with Vision Service Plan at the premium rates of \$6.37 per month for the single plan and \$37.05 per month for the family plan through August 31, 2011,

BE IT FURTHER RESOLVED, that the Township portion will continue to be 90% and the employee portion will be 10%.
