FY2008 Safer Grant: Michael T. Sacksteder


WHEREAS, on May 15, 2009, the Sugarcreek Township Board of Trustees approved

date of September 6, 2010, with a one (1) year probationary period ending on September 6, 2011.


BE IT FURTHER RESOLVED, that part-time township employees are hired with the

in any year, calculated annually from the date of part-time appointment.






