
IN RE: Parity Increase for Part-time Fire Department Personnel Modifying the Wage Scale


WHEREAS, this Board of Township Trustees is committed to dealing equitably with Township employees in matters effecting their employment, retention and well-being; and,

- Both Certified Inspector/Instructor = Bonus Rate \$0.60 per hour, payable the first full pay period in December of each year
